- Food sales requirements and reporting;
- Quarterly statement filings; and
- Books and records tracking.

There will be two sessions held on the same day: the first session will be held from 9:00 a.m. - 11 a.m. (Spanish interpreter available); the second session will be held from 2:00 p.m. - 4:00 p.m. (Korean interpreter available).
